2. Background

The Mangosuthu University of Technology (MUT) is about to implement 3 number of 5 Storey Student Residence Blocks within the existing Main Campus, situated at 511 Griffiths Mxenge Highway, Umlazi, Durban. The project requires a Geotechnical Investigation undertaken by services of a Professional Geotechnical Engineer to inform the Civil and Structural Engineering aspects and provide guidance on geotechnical project related matters.

3. Scope of Service

Assumed Loading

The anticipated new load-bearing brickwork and columns (service) loads are approximately 250, 500, 1000, 1500, 2500 kN vertical load and a linear load of 75, 120, 200, 400 kN/m. Our maximum differential settlement must be limited to **10mm**. All loads will be confirmed once the service provider is appointed.

A 'phased' approach is to be adopted for the geotechnical investigation as follows:

Phase 1 Geotechnical Investigation – Shallow Investigation: Minimum Requirements

Inter-alia, we require the following data to be presented in a detailed geotechnical report:

- Maximum net allowable bearing capacity of the in-situ soils. This will include possibility for light foundations e.g. generator rooms, single storey structures, lightly loaded retaining walls etc.
- Settlement/heave – differential and total.
- Comment on possible founding solutions. Including a 'full' detailed geotechnical design of the:
 - 'ground improvement system' or
 - 'engineered fill' required, if it forms part of your foundation recommendations in your Phase 1 Geotechnical Report.
- Comment on sub-soil/sub-grade conditions and general geology.
- Depth to groundwater table.
- Comment on excavation procedure of the in-situ soils – including advice in terms of blasting or removal of hard rock if it is encountered at very shallow depths below existing ground level, where applicable. If applicable, we will require detailed specifications for blasting as an option.
- Material classification of in-situ soils and comment on the suitability of in-situ soils for usage on-site earthworks / layerworks.
- Comment on overall stability of the site including carrying out 'slope stability' analysis where applicable.
- All parameters / indices for the design of retaining walls.
- Soil permeability tests to assess on-site percolation.
- Allow for excavation of 20 no. off inspection pits for the Phase 1 geotechnical investigation (excluding pits required for bullet 6 above).

The following laboratory tests are required, but not limited to the following:

- Foundation Indicator Tests. (Allow for 10 no. off).
 - Note: allow for 3 of the above to be undertaken at approximately 3.0 meters below Natural Ground Level.
- Roadworks Indicator Tests. (Allow for 5 no.)
- Mod AASHTO Density Tests for the various soil types. (Allow for 10 no.)
- CBR Tests (allow for 10 no.)
- Swell potential tests (if clayey subsoils are encountered). (Allow for 8 no.)
- Standard Oedometer tests. (Allow for 5 no.)
- Triaxial tests (consolidated drained tests with pore water pressure measurements).
- UCS tests on rock/cement stabilized material samples (allow for 6 no.), If rock is encountered at shallow depths below existing ground level.
- Point load tests on rock cores. (Allow for 6 no.), if encountered

Phase 2 Geotechnical Investigation – Deep ‘Borehole’ Investigation

Should the results of the Phase 1 Geotechnical Investigation prove inconclusive or if shallow bedrock is not encountered, we will require a Phase 2 Geotechnical Investigation which entails ‘borehole’ drilling, profiling and testing such that all data as per Phase 1 above, can be determined.

At least 5 No. boreholes will be required to be drilled to a depth of at least 15 meters below the existing ground level or prove at least 3 meters of competent weathered bedrock. Standard penetration tests and undisturbed sampling should be allowed for in each of the boreholes. A piezometer must be installed on completion of the borehole to measure groundwater levels.

***** Note to take into consideration when pricing:**

- The Geotechnical Engineer must provide a quotation (clearly marked: Phase 1 Geotechnical Investigation - Shallow Investigation), including all timeframes to undertake the above task.
- The Geotechnical Engineer must also provide a separate quotation (clearly marked: Phase 2 Geotechnical Investigation – Deep ‘Borehole’ Investigation), including all timeframes to undertake the above task. This quotation is required to facilitate the Client review and approval process, should the results of the Phase 1 Geotechnical Investigation prove to be inconclusive or if shallow bedrock is not encountered.
- This brief for the proposed geotechnical investigation is not exhaustive. The geotechnical engineer may add any item that will add value to the investigation.
- The Geotechnical Engineer is to ensure compliance in terms of all Occupational Health and Safety Requirements during the investigation. A construction sequence for all site activities, including details of all personnel and plant, must be submitted for approval prior to site work commencing. A health and safety file must be priced accordingly.
- The Geotechnical Engineer must ensure all areas of investigations are to be scanned using GPR scanning in order to avoid risks of obstructions/services and delays.
- All locations (approximate positions) will be provided to the awarded bidder.
- All inspection pits must be re-instated and made safe.
- All testing requirements (i.e. no. of tests) to be verified and confirmed by Civil and Structural Engineer upon appointment of service provider.
- Bidders are to attach a full cost breakdown to their response to the RRQ.

CERTIFICATE OF INDEPENDENT BID DETERMINATION
