Mangosuthu University of Technology has recognized the necessity to upgrade the biomedical laboratories of the institution for its student pupils. The laboratory upgrades have been divided into two phases, with the first phase already completed, and the second phase set to begin. The services of a Health & Safety consultant are required to oversee the project through construction and the facilitation of closing out the project.

The scope entails the provision of Health and Safety services for the Renovations of Biomedical Laboratories Phase 2, within the premises of Mangosuthu University of Technology main campus. The services will be required from stage 5(Construction) to stage 6(Close-out).

- Use of trends analysis to identify system deficiencies and incident trends, outline relevant improvement.
- Facilitate construction Health and Safety system and plans reviews and ensure changes are incorporated for continual improvement.
- Development of Technical Reports in relation to Health and Safety issues and communicate through presentations to diverse groups of decision makers.
- Perform incident and accident investigations where necessary.
- Monitor the compilations of the Construction Project Health and Safety File(s) by the Contractor(s).

CERTIFICATE OF INDEPENDENT BID DETERMINATION

- 1 This document must form part of all bids¹ invited.
