The Faculty of Natural Sciences at Mangosuthi University of Technology (MUT) is facing a shortage of office space for its academic staff. To address this issue, the infrastructure department has decided to demolish the existing classroom facilities and construct a new lightweight structure to create additional office space. This decision has been made in consultation with the end-user department to provide offices for the staff members who need them.

## CERTIFICATE OF INDEPENDENT BID DETERMINATION
