Mangosuthu University of Technology wishes to appoint a suitably qualified and experienced service provider to Supply, Deliver, Install and Commission a hired 250kVa standby generator for a period of Five days.

Supply, Deliver, Install and Commission a hired 250kVA 3 phase standby generator for 5 days with the ffg: -

- Full Tank Diesel.
- Auto transfer Switch.
- An Electrical COC.
- Drip Tray or any means to contain diesel leaks.
- Lead cables to be at least 30m

**NB: The generator to be connected, tested & a COC issued on the 15<sup>th</sup> of April and ready for operation on the 16<sup>th</sup> of April 2024.**

## **CERTIFICATE OF INDEPENDENT BID DETERMINATION:**

1. This document must form part of all bids<sup>1</sup> invited.
2. Section 4 (1) (b) (iii) of the Competition Act No. 89 of 1998, as amended, prohibits an agreement between, or concerted practice by, firms, or a decision by an association of firms, if it is between parties in a horizontal relationship and if it involves collusive bidding (or bid rigging).<sup>2</sup> Collusive bidding is a *pe se* prohibition meaning that it cannot be justified under any grounds.
