## CERTIFICATE OF INDEPENDENT BID DETERMINATION

## WHAT IS THE MUT LOOKING FOR

Appointment of a Tree Felling, Lifting and Pruning Service Provider for a one-time contract at MUT wide.

### Specification:

#### 1. Tree Felling, Lifting and Pruning

Tree felling, lifting, and pruning: The identified trees shall be felled, lifted and pruned to remove branches that overhang onto buildings and to ensure the safety and structural integrity of the university buildings.

Pruning Techniques: The contractor shall employ appropriate pruning techniques to minimize damage to the trees and to promote healthy growth.

Safety Measures: The contractor must ensure the safety of personnel and prevent property damage during the tree-cutting process. This includes using appropriate rigging and lowering techniques when necessary.

#### 2. Debris Removal

Debris Collection: All cut branches and debris generated during the tree-cutting process shall be collected promptly.

Debris Disposal: Debris shall be removed from the project site and properly disposed of in accordance with local regulations and environmental guidelines. **All debris to be cleared on-site.**

#### 3. Safety and Compliance

Personnel Safety: All personnel involved in the project must wear appropriate Personal Protective Equipment (PPE) at all times, including helmets, safety glasses, gloves, and safety vests.

Occupational Health and Safety: The contractor shall comply with all relevant Occupational Health and Safety regulations. OHS protocols must be strictly adhered to throughout the project. The contractor to provide the personnel working at heights certificates.

Property Protection: The contractor must take measures to protect university property, including buildings, walkways, and landscapes, from damage during the tree-cutting process.

#### 4. Site Clean-up

Job Site Cleaning: Upon project completion, the contractor shall ensure that the job site is cleaned thoroughly, and no debris or cut branches are left behind.

#### 5. Insurance

5.1. Insurance Coverage: The contractor must provide evidence of valid and active insurance coverage (R1 million) to repair or restore any structures or property that may be damaged or disturbed during the performance of the work. This insurance must meet the satisfaction of Mangosuthu University.
