**2. Background**

The Mangosuthu University of Technology (MUT) Block H student residence upper levels are in a state of decay, as the deteriorating waterproofing has contributed to constant water ingress. The damage to the interior of the residences has created poor living and health conditions for the students, as such the residences have become inhabitable. MUT has seen it as emergency work to be conducted on the Block H residence roof, and the services of a Structural Engineer are required to see the work is conducted accordingly.

## CERTIFICATE OF INDEPENDENT BID DETERMINATION

- 1 This document must form part of all bids<sup>1</sup> invited.
