2. Background

The Mangosuthu University of Technology (MUT) is improving its bulk water system and has made a provision to increase its water storage capacity to supply the main campus. An elevated steel tank and associated infrastructure is required to achieve this to accommodate the increasing development within the University.

3. Scope of Service

Location of Site:

The project is located at MUT, Umlazi, KZN. The attached Google Earth KMZ file named “Survey RFQ – MUT – 13.06.2024” includes the approximate extent for the required area to be surveyed. The required survey extent (blue) can also be seen in figure 1 below.

The scope of work is as follows:

A topographical survey is to be conducted within MUT for approximately 21700m² area, as displayed in the attached kmz file. This activity will fill in the gaps in the existing survey information. The existing survey information is provided in the .xml file titled “P19119-CM-03-NGL SURVEY-2020-01-01-SITE SURVEY”. The information captured under this activity will need to be merged with the existing survey information.

Topographical survey points would typically include existing buildings, existing services, including sewer pipelines with manhole inverts and cover level, including materials and diameter, road edges and dividing line, pipe culverts with invert levels, storm water services, ablution facilities, trees, fences and gates, all services (Telkom poles, Electricity poles and their back stay anchor points, light poles, etc.) including manholes covers, drainage paths, open Stormwater channels, cut and fill slopes, valves, pipe markers, test posts, river beds and any additional structures within the survey area.

The survey work includes the provision of a fully constructed (i.e., all feature / breaklines done) and triangulated digital terrain model (DTM) and a CAD file in AutoCAD .DWG or .DXF format with all information reflected in the correct layers. A full description of all survey codes and symbols used is to be provided by the Surveyor. The DTM shall be provided in a BOT, TOT, CSV, or XML file, and must include triangulation information. The final survey submission must be merged with the existing survey provided. The final, complete survey to be supplied on a usb or via wetransfer.

CERTIFICATE OF INDEPENDENT BID DETERMINATION
