The MUT North Campus storage water tank is not in good condition. Some leakages have been identified as well as corroded areas within the tank. MUT requires an assessment to be done on the water tank, to explore options on whether it can still be refurbished or a new one needs to be procured. The size of the tank is about 0.3ML and is meant to operate as a backup to supply the North Campus during water outages.

CERTIFICATE OF INDEPENDENT BID DETERMINATION

- 1 This document must form part of all bids¹ invited.
