2. Background

Following an audit, it was determined that the current state of the Biomedical laboratories at Mangosuthu University of Technology falls below the required HPCSA standards for laboratory teaching and learning. Thus, it is crucial that we upgrade these facilities to better serve the academic needs of our students and faculty. MUT is currently undertaking the Renovations to the Biomedical Laboratories, and the project requires the service of a Mechanical Engineer to perform the Fire Engineering services for the same.

The Fire Engineer is tasked with evaluating the current fire safety system in place at the Biomedical Laboratories and providing recommendations for necessary improvements. Subsequently, the Engineer will be required to generate detailed design drawings detailing the construction work

CERTIFICATE OF INDEPENDENT BID DETERMINATION

- 1 This document must form part of all bids¹ invited.
