## CERTIFICATE OF INDEPENDENT BID DETERMINATION

- 1 This document must form part of all bids<sup>1</sup> invited.

## WHAT IS THE MUT LOOKING FOR

Appointment of a suitable service provider for Sewer extraction(removal) and disposal from conservancy tank services.

### Specification:

Sewer extraction a **56m<sup>3</sup> (56 000L)** conservancy tank once a week (Every 4<sup>th</sup> day) or when required by MUT.

### NB: (item 1 and2)

- Every 4<sup>th</sup> Day MUT representative to verify with the contractor the actual quantities (Litres of sewage extracted). The amount to be involved will be based on sewage extracted.
- The unit rate for travelling to be applicable in line with the actual kilometres travelled.

### NOTE:

- Sewer extraction will be performed from MUT New Engineering Building.
- An additional conservancy tank with the estimated capacity of **67,5m<sup>3</sup>** at the New Student Centre Building will be included in the scope and rates quoted will be applicable.
- The successful bidder shall prepare and submit a safety file with all relevant documentation.
- The successful bidder will sign section 37(2) agreement with the client after verification of the safety file and thereafter be issued with a permit to commence work if the safety file has been checked and approved by the client.
- **Failure to provide the safety file will result in withdrawal of the award letter and purchase order.**
