CERTIFICATE OF INDEPENDENT BID DETERMINATION

- 1 This document must form part of all bids¹ invited.

MUT requirements:

MUT would like to contract a service provider to supply, install, configure, and maintain an infrastructure and applications performance monitoring solution.

Technical Specifications

The technical and functional specifications for the required system are detailed below and it must be noted that these are the minimum requirements. The only deviation that will be accepted will be in a case where the bidder's offering or proposal is better, anything below the minimum technical and functional specifications will be disqualified.

The solution must assist MUT to achieve the following high level objectives:

Servers Health - The solution must provide real-time insights into the health and utilization of servers, including CPU usage, memory utilization, and disk space. This will enable MUT to identify potential issues with server capacity and ensure application performance is not affected.

Optimize applications and network performance - By monitoring metrics like response times and network availability, MUT can identify areas for improvement and fine-tune our applications and network infrastructure accordingly.

Identify bottlenecks, congestion and other issues - By monitoring metrics such as network traffic, latency, bandwidth usage and packet loss; the solution must assist MUT to identify and correct bottlenecks, congestion and other issues that may degrade the network performance.

Assist with capacity and scalability planning - The solution must provide insights on the use of the networks, infrastructure, and applications. By analysing historical performance data and trends using artificial intelligence, MUT must be able to forecast future infrastructure requirements and make informed decisions regarding network upgrades, bandwidth allocation, and other infrastructure investments.

The solution proposed must be technology agnostic, i.e. system must be able to monitor and report on the performance on a variety of technologies deployed at MUT's IT environment including routers, switches, servers (both remote and local), Virtual Machine (VM) environment, Wide Area Network, Local Area Network, printers, firewalls, application performance, database performance and Storage Area Network (SAN).

MUT would like to set up a Network Operations Centre (NOC) to centralise the monitoring of the network of the different components of the network.

The solution must provide a dashboard that provides a full view of the entire IT environment on one panel of glass to make it easier to identify faults. There must also be business views for all the different locations. The dashboard should be web based and optimized to be accessed through various platforms including mobile devices. Lastly, the solution must

enable internal staff to draw reports; create dashboards through its built in feature.

There will be 4 x screens, attached to PC's that will be used to display these dashboards.
