CERTIFICATE OF INDEPENDENT BID DETERMINATION

- 1 This document must form part of all bids¹ invited.

1. Background and Introduction

MUT is currently utilizing a Siemens Hi Path 4000 Telephone System and requires SIP trunk services to enhance communication capabilities. The proposed solution must meet technical, performance, and redundancy requirements while ensuring compatibility with the existing infrastructure.

2. Scope of Work

The successful bidder will be required to provide the following:

- a) **Voice and Telephone Services:**
 - Integration with existing Siemens Hi Path 4000 system.
 - Support for inbound and outbound calls using SIP trunks.
 - Compliance with E.164 Numbering Plans for efficient call routing.
- b) **Bandwidth Requirements:**
 - Primary trunk link with a minimum bandwidth of 100 Mbps.
 - Redundant trunk link with a minimum bandwidth of 50 Mbps to ensure failover capability.
- c) **Call Rate Submission:**
