The Infrastructure department at Mangosuthu University of Technology (MUT) is collaborating with relevant stakeholders to renovate the Hlanganani Canteen, which is in poor condition.

**3. Scope of Service**

The scope of services includes providing Civil Engineering services from Stage 1 (Inception) to Stage 6 (Close Out), in accordance with the standards set by the Engineering Council of South Africa (ECSA) 2021. The Civil Engineering services will focus on stormwater drainage for the catchment area, utilizing a stormwater grid channel at the entrance of the canteen. Additionally, a

trunk main will be installed beneath the canteen building to direct the flow to the outlet. This scope also covers all stormwater pipes that connect to the trunk main leading up to the outlet. The services required also includes for the design of a retaining wall system that corresponds with the architectural design, localized water drainage on the first floor of the building and a comprehensive stormwater reticulation design

## CERTIFICATE OF INDEPENDENT BID DETERMINATION

- 1 This document must form part of all bids<sup>1</sup> invited.
