2. Background

Mangosuthu University of Technology (MUT) is currently experiencing a shortage of on-campus student accommodation. In response to this challenge and in alignment with its strategic enrolment objectives, the University has initiated an expansion project aimed at increasing on-campus housing capacity. As part of this initiative, MUT intends to construct a new student residence facility that will provide accommodation for 100 students.

3. Scope of Service

The scope of work entails the provision of Project Management Services, to be undertaken from **Stage 5** (Construction) through to **Stage 6** (Close-Out), in accordance with the 2019 guidelines and deliverables prescribed by the South African Council for the Project and Construction Management Professions (SACPCMP). The appointed service provider shall also perform a complete review of stage 4 tender information as part of services.

The project involves the construction of a five-storey, concrete-framed building. The design incorporates a central circulation core servicing all floors of the building, which includes a main staircase, as well as dedicated fire escape staircases to ensure compliance with health and safety standards.

The New 100-Bed Student Residence will comprise the following amenities:

- Fully furnished student bedrooms
- Communal ablution facilities
- Kitchenettes
- Designated study areas
- Television lounges
- Universal access for persons with disabilities

CERTIFICATE OF INDEPENDENT BID DETERMINATION
