CERTIFICATE OF INDEPENDENT BID DETERMINATION

3.2 The maximum possible score that can be achieved for price is 80 points.

NB: Bidders are required to, together with their bids, submit original and valid B-BBEE status level verification certificates or certified copies to substantiate their B-BBEE rating claims. A bid will not be disqualified from the bidding process if the bidder does not submit a certificate substantiating the B-BBEE status level of contribution nor is a non-compliant contributor.
