# 2. Background

Mangosuthu University of Technology has recently completed renovations in a section of its biomedical laboratories, following an audit that revealed the facilities did not meet the required HPCSA standards. The university is now focused on completing the entire biomedical facility to ensure compliance with all relevant regulations. This commitment reflects MUT's dedication to the safety and well-being of both students and staff in all university buildings.

The project involves refurbishing the final phase of the Biomedical Laboratories on the main campus. The lab will serve as both a research facility and a Molecular Biology Laboratory, with separate dirty and clean areas and an ablution facility. The project is expected to take approximately 5 months, with completion anticipated in December 2025.

### 3. Scope of Service

The architectural service provider is required to conduct a thorough investigation and identify the existing services, layout, and functionality. Subsequently, the provider shall produce a design for the new room layout in relation to the renovations of the Biomedical Laboratories. Architectural services are to be rendered from Stage 1 (Inception) through Stage 6 (Close Out) in accordance with the standards established by the South African Council for the Architectural Profession (SACAP) 2024, along with the expected deliverables for each respective stage.
