**2. Background**

An audit that was conducted at the Biomedical Laboratories at Mangosuthu University of Technology, deemed that the laboratories fell below the prescribed HPCSA standards and were unsuitable for conducting classes. After this report, MUT has redeveloped Two out of Three of the Biomedical Laboratories and is moving forward with the redevelopments of the final phase (Phase 3), as it aims to create a modern, safe, and functional learning environment that complies with the HPCSA standards for laboratory Research, Teaching, and Learning. ### CERTIFICATE OF INDEPENDENT BID DETERMINATION
