The current ablutions and wall finishes have been in service for several years and no longer meet acceptable standards for hygiene, appearance, and durability. The refurbishment project aims to upgrade these areas into clean, well-maintained, and efficient spaces that support a comfortable environment for students and staff.

The successful Quantity Surveyor will be required to:

1. Conduct an assessment of the existing training laboratories to identify defects, damages, and necessary repairs.
2. Prepare a comprehensive report detailing the findings, recommended repairs, and associated costs.

## CERTIFICATE OF INDEPENDENT BID DETERMINATION
