## **BACKGROUND:**

Scope of Work: Provision of Networking and Telephone Cabling Services

### **Introduction:**

Mangosuthu University of Technology (MUT) is seeking to engage a qualified and experienced service provider to render networking and telephone cabling services for the institution for one (1) year. The appointed service provider will be expected to ensure continuity and reliability of MUT's network and telephony infrastructure through routine maintenance, fault repairs, ad hoc installations, and equipment supply.

### **Scope of Services:**

The successful service provider will be expected to perform the following services:

**1. Deployment of On-Site Technician**

Provide two (2) full-time technicians with a valid Network and Telephone Cabling Certificate (minimum NQF Level 3) stationed at MUT during normal business hours (Monday to Friday, 08h00–16h00).

**2. Network Cabling Repairs**

Attend to and resolve all network cabling faults and maintenance issues on campus, ensuring minimal service interruption.

**3. Telephone Cabling Repairs**

Troubleshoot and repair faults related to telephone cabling to ensure clear and consistent voice communication across the university.

**4. Fibre Optic Repairs and Maintenance**

Manage repairs to the fibre optic network infrastructure, including splicing, patching, and testing where applicable.

**5. Supply of Networking and Cabling Equipment**

Provide specialised networking equipment, cabling, connectors, and related components as per the University's needs and approved bill of quantities.

**6. Ad Hoc Installations**

Perform ad hoc network or telephony cabling installations (e.g., new office setups, lab expansions), subject to approval by MUT's delegated authority.

**7. After-Hours Emergency Support**

Respond to emergency work requests outside normal working hours or over weekends, based on mutual agreement and subject to overtime approval.

**8. Documentation and Reporting**

Submit daily signed timesheets as proof of attendance and completed job cards for all tasks performed. Maintain clear and traceable service records.

**9. Service Review and Collaboration**

Attend monthly service review meetings with MUT’s IT technical team to assess service delivery, address concerns, and identify areas for improvement.

**10. Call Logging and Ticketing System**

Implement a call logging system for tracking and managing all service requests. All calls must be logged, assigned a reference number, and resolved within agreed SLA timelines. The service provider must update each ticket with status reports and resolutions.
