Mangosuthu University of Technology wishes to appoint suitably qualified and experienced service provider for the sewer extraction and disposal services from the conservancy tank on an as-and-when-required basis for a period of six (6) Months or until the RFQ financial threshold is reached, whichever occurs first.

## Specification/Scope of Work:

Sewer extraction a **56m3 (56 000L)** conservancy tank once a week (Every 4<sup>th</sup> day) or when required by MUT.

### **NB: (item 1 and2)**

- Every 4<sup>th</sup> Day MUT representative to verify with the contractor the actual quantities (Litres of sewage extracted). The amount to be involved will be based of sewage extracted.
- The unit rate for travelling to be applicable in line with the actual kilometres travelled.

### NOTE:

- Sewer extraction will be performed from MUT New Engineering Building.
- An additional conservancy tank with the estimated capacity of **67,5m3** at the New Student Centre Building will be included in the scope and rates quoted will be applicable.
- The successful bidder shall prepare and submit a safety file with all relevant documentation.
- The successful bidder will sign section 37(2) agreement with the client after verification of the safety file and thereafter be issued with a permit to commence work if the safety file has been checked and approved by the client.
