CERTIFICATE OF INDEPENDENT BID DETERMINATION

- 1 This document must form part of all bids¹ invited.

1. WHAT IS THE MUT LOOKING FOR

Mangosuthu University of Technology wishes to appoint suitably qualified and an accredited service provider to facilitate, assess and moderate.

2. SCOPE OF WORK

The appointed service provider shall render a turnkey learner development service for 15 learners as follows:

- Chemical Operations NQF Level 3 – 8 learners
- Chemical Operations NQF Level 4 – 7 learners

2.1 Training Delivery

The service provider must:

1. Facilitate structured learning for the applicable Chemical Operations qualification/programme in line with the relevant curriculum, qualification rules, and quality assurance requirements.
2. Provide suitably qualified and competent facilitators, assessors, and moderators for the relevant programme.
3. Develop and submit a detailed training implementation plan indicating:
 - learning schedule,
 - training methodology,
 - assessment plan,
 - moderation plan,
 - learner support arrangements,
 - workplace placement plan, and
 - reporting schedule.

2.2 Learner Support Material

The service provider must:

- Provide all required learner support material / study material aligned to the qualification or programme being delivered.
- Ensure that training manuals, learner guides, assessment tools, and related instruments are adequate for the knowledge, practical, and workplace components of learning.

2.3 Assessment and Moderation

The service provider must:

- Conduct learner formative and/or summative assessments in accordance with the applicable quality assurance requirements.
