CERTIFICATE OF INDEPENDENT BID DETERMINATION

- 1 This document must form part of all bids¹ invited.

- 2 Section 4 (1) (b) (iii) of the Competition Act No. 89 of 1998, as amended, prohibits an agreement between, or concerted practice by, firms, or a decision by an association of firms, if it is between parties in a horizontal relationship and if it involves collusive bidding (or bid rigging).² Collusive bidding is a *pe se* prohibition meaning that it cannot be justified under any grounds.

WHAT IS THE MUT LOOKING FOR:

Appointment of a suitable and qualified service provider for Annual Physical Asset Verification of movable assets for 2026 financial year for a period of Five (5) months.

SPECIFICATION/SCOPE OF WORK/DELIVERABLES:

- MUT requires the services of a suitably qualified service provider with proven financial expertise, experience in fixed asset management, asset verification and up to date advanced technology, to conduct the annual physical asset verification of all movable assets for 2026 financial year.
- The service provider to assist account for approximately 50 000 assets and report on the movement on the fixed asset register, incorporating assessment of useful life, and impairment testing.
- The service provider to perform these assessments and assist with translating the verification findings into the MUT Assets Management system, reconciling the assets and assist with AFS and Audit queries.
- Assess and provide recommendations for improvements to the current fixed assets policy, asset management and asset disposal process.
- Perform IFRS 16 working (schedules) and disclosures for the annual financial statements.
- Identify obsolete assets for management attention.

All received bids will be evaluated in terms of the 80/20-point system as stipulated in Preferential Procurement Regulations, 2017. 80 points will be allocated for price and 20 points for attaining the B-BBEE status level of contributor.

3.1 Points for price will be calculated only for shortlisted bidder/s as follows:

$$P_s = 80 \left(1 - \frac{P_t - P_{\min}}{P_{\min}} \right)$$

Where:

P_s =Points scored for competitive price of bid or offer under consideration

P_t =Competitive price of bid or offer under consideration; and

P_{\min} =Competitive price of lowest acceptable bid or offer

3.2 The maximum possible score that can be achieved for price is 80 points.

NB: Bidders are required to, together with their bids, submit original and valid B-BBEE status level verification certificates or certified copies to substantiate their B-BBEE rating claims. A bid will not be disqualified from the bidding process if the bidder does not submit a certificate substantiating the B-BBEE status level of contribution nor is a non-compliant contributor. Such a bidder will score zero out of maximum 20 points for B-BBEE.
