The training must cover on-air presentation and voice technique, content production and show planning, technical operation and troubleshooting, live broadcast management, and broadcasting regulatory and ethical awareness.

Target participants are MUT Radio on-air presenters and hosts, producers and content/news team members, technical and broadcast operators, and the Station management. Total of 25 participants.
